^{*} The IRS has not issued guidance as to the application of Section 1061 to REIT capital gain dividends. For information purposes only, it is estimated that 3.89% of each distribution identified as capital gain with respect to either GGP Inc. or Brookfield Property REIT Inc. common and preferred shares in 2018 was derived from certain assets held by Brookfield Property REIT Inc. and its affiliates for less than three years. This issue is complex and there is substantial uncertainty as to the application of the statute. Shareholders should consult with their tax advisors.
